Bluegrass Water Utility Operating Company, LLC (Bluegrass Water) is hereby notified that it has been named as a Defendant in a formal complaint filed on April 8, 2025, a copy of which is attached as an Appendix to this Order and incorporated herein.

The Commission finds that pursuant to 807 KAR 5:001, Section 20, Bluegrass Water should satisfy the matters complained of or file a written answer to the complaint within ten days from the date of service of this Order. The Commission directs Bluegrass Water to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission.

Sewer Backup Incident Report

Summary of Events and Actions Taken

On a March 16th, 2025, a significant sewer backup occurred, resulting in approximately 8 inches of water backing up into the finished basement. The homeowners' son and POA, Charles M Tackett, II, along with the assistance of his daughter, spent the following two days diligently removing the water. To aid in this effort, they utilized a new shop vac, mops and buckets, three new dehumidifiers, and carpet drying fans.

Inspection and Response


On Thursday, March 20th, a private plumber from Bevo Plumbing was hired by Mr Tackett to inspect the sewer line. During the inspection, it was discovered that the lateral line leading to 2029 Longview Dr was free of debris and free flowing. However, the main line, which is under the jurisdiction of Bluegrass Water Utility Co, was found to be obstructed by tree roots.

Utility Company Action

The following day, on March 21st, Bluegrass Water Utility Co was onsite to address the issue. Using their cameras, they confirmed the presence of tree roots infiltrating the sewer line, causing the blockage. The utility company demonstrated the problem and began taking steps to rectify the situation.

This incident highlights the importance of regular maintenance and prompt response to sewer line issues to prevent significant property damage and restore normalcy efficiently.
