ORDER

On July 3, 2025, East Casey County Water District (East Casey District) filed a motion that requested an extension of time to fully respond to Commission Staff's First Request for Information (Staff's First Request), Item 3, and also requested an informal conference (IC) with Commission Staff.¹ East Casey District timely filed its responses to Staff's First Request on July 3, 2025, excepting Item 3. Due to its incomplete response to Staff's First Request, Item 3, East Casey District requested an extension of time until after the IC is held to provide a full and complete response to this request for information.

East Casey District stated it could not provide a full response to Staff's First Request, Item 3, within the time allotted in the procedural schedule because its bookkeeper was on vacation during this time, and no other employee had the expertise to extract information from East Casey District's billing system to make it available to the Commission.² Furthermore, East Casey District requested that the Commission schedule

an IC for the purpose of enabling East Casey District to provide information responsive to Staff's First Request, Item 3, and to expedite the resolution of this proceeding.³

Based upon the motion, the Commission finds that there is good cause to grant East Casey District's motion for an extension of time to fully respond to Staff's First Request, Item 3. The Commission also finds East Casey District established good cause to schedule an IC, and therefore, the motion should be granted. An IC is scheduled on July 23, 2025, at 10 a.m. Eastern Daylight Time. Commission Staff will contact participants by electronic mail to provide details for joining the conference by video link.

IT IS THEREFORE ORDERED that:

- East Casey District's motion for an extension of time to respond to Staff's First Request, Item 3, is granted.

 - 3. An IC is scheduled on July 23, 2025, at 10 a.m. Eastern Daylight Time.
