ORDER

On May 28, 2025, Burkesville Gas Company, Inc. (Burkesville) filed its Gas Cost Recovery (GCR) rate report for rates with a proposed effective date of June 28, 2025. Burkesville's previous GCR rate was approved in Case No. 2025-00047.¹

LEGAL STANDARD

The Commission's standard of review for GCR rates is well settled as stated in KRS 278.274(1):

In determining whether proposed natural gas utility rates are just and reasonable, the commission shall review the utility's gas purchasing practices. The commission may disallow any costs or rates which are deemed to result from imprudent purchasing practices on the part of the utility.

Further, the utility has the burden to prove the rates are just and reasonable and the Commission may reduce the purchased gas component of the utility's rates, or the rates charged by an affiliated company to the extent the amount is deemed to be unjust or unreasonable.²

DISCUSSION

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that Burkesville's report includes revised rates designed to pass on to its customers its expected change in gas costs. Burkesville's report sets out an Expected Gas Cost (EGC) of \$9.6513 per Mcf, which is an increase of \$0.9169 per Mcf from the previous EGC of \$8.7344 per Mcf. Burkesville's report sets out no Refund Adjustment. Burkesville's report sets out a current quarter Actual Cost Adjustment (ACA) of \$0.8289 per Mcf. Burkesville's report sets out a current quarter Actual Cost Adjustment \$0.8289 per Mcf. In calculating its total ACA, Burkesville erroneously included an incorrect amount of (\$0.000) per Mcf for the Third Previous Quarter ACA. The correct Third Previous Quarter ACA is \$0.0431 per Mcf as approved in Case No. 2024-00166.³ Correcting this produces a total ACA of \$1.0588 per Mcf, which is an increase of \$0.8289 per Mcf from its previous total ACA of \$0.2299 per Mcf.

Based on the calculations above, the Commission finds that Burkesville's corrected GCR rate is \$10.7101 per Mcf, which is an increase of \$1.7458 per Mcf from the previous GCR rate of \$8.9643 per Mcf. The Commission further finds that the rates set forth in the Appendix to this Order are fair, just and reasonable and should be approved for service rendered by Burkesville on and after June 28, 2025.

For the purpose of transparency and to maintain a record of information for future use, the Commission finds that Burkesville shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future

GCR rate reports. Should Burkesville purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Burkesville are denied.
2. The rates set forth in the Appendix of this Order are approved for service rendered on and after June 28, 2025.
3. Burkesville shall submit all invoices it receives along with its monthly usage reports for each month of the reporting period when it files its future GCR rate reports.
4. Should Burkesville purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount shall be documented in its cover letter to the Commission.
5. Within 20 days of the date of service of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
6. This case is closed and removed from the Commission's docket.
