RE: Informal Conference of August 26, 2025

Pursuant to an Order issued on August 14, 2025, an informal technical conference (ITC) was conducted on August 26, 2025. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss East Kentucky Power Cooperative's (EKPC) Application for a General Adjustment of Rates and for EKPC to provide a technical presentation of the financial schedules included with the application. EKPC presented the proposed tariff changes and discussed the proposed Times Interest Earned Ratio (TIER). EKPC further discussed the revenue requirement, including the regional transmission expansion plan (RTEP) Tracker, Generation Maintenance Tracker, proposed adjustments, and the regulatory assets. EKPC then presented the cost-of-service study which included discussions regarding demand related costs, energy related costs, customer related costs, and the cost-of-service model. Additionally, EKPC discussed the pass-through rates including wholesale versus retail and fielded questions from all parties.

There being no further discussion, the informal conference was then adjourned.
