IT IS THEREFORE ORDERED that:

1. Post-hearing requests for information, if any, shall be filed on or before December 19, 2025.
2. Responses to post-hearing requests for information shall be filed on or before December 30, 2025.
3. Counsel for Duke Energy Ohio shall file a memorandum brief in support of Duke Energy Ohio's post-hearing position on or before December 23, 2025.

4. This case shall stand submitted for a decision by the Siting Board effective 12:01 a.m. Eastern Standard Time, December 31, 2025.




