I am on a fixed income. I am on auto pay for my electric. I have the set amount monthly with a annual fee for any overage price. I live in 1100 sq ft home with electric only. My bill is \$198.00 a month and my running average that I have to pay annually is \$700 or more extra. I have had a request for a new electric pole for almost a year. It still hasnt been replaced even though a week after I made the request a man for the electric company came out, verified the pole needed replaced (its from the 60s) and leaning on a building I need to take down but cant because of this pole. If you ride along 460 towards mouth card ky, you will see lines on the ground, trees laying on them in many, many places. I purchased a whole home generator because the electric goes out a lot around here. You wont take care of the holler people but you will rate hike us just for living here. I moved from Arizona where we were part of a co-op. That means I was part owner in that electric company. I received a small check every year from this co-op and I lived in a 2400 sq ft home without ever paying more than \$200 a month during peak season. Your rate hike of more than 30% in the last 3-4 years is ridiculous. Do not do this. Its wrong.
