ORDER

The Commission, on its own motion, finds that a procedural schedule should be established for the orderly processing of this case. The procedural schedule is attached as an Appendix to this Order.

The Commission also finds that the next in-person update should take place on October 14, 2026, at 9 a.m. Eastern Daylight Time, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky. Two weeks prior to the in-person meeting, the Commission directs Commission Staff to draft an agenda and file it into the record prior to the meeting in addition to filing a memorandum into the record after the update. Commission Staff will contact participants by electronic mail to provide details for joining the conference by video link. Parties wishing to attend virtually should inform Commission Staff of their desire to do so.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in the Appendix to this Order shall be followed.

2. The next in-person update shall be held on October 14, 2026, at 9 a.m. Eastern Daylight Time, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

3. LG&E/KU shall respond to all requests for information propounded by Commission Staff, whether identified on the procedural schedule or otherwise, as provided in those requests.

4. Any party filing a paper with the Commission shall file an electronic copy in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085<sup>1</sup> regarding filings with the Commission.

5. Commission Staff shall file an agenda into the record two weeks prior to the in-person update.

6. Parties wishing to attend virtually shall inform Commission Staff of their desire to do so.
