RE: Informal Conference of March 19, 2026

On March 16, 2026, Bluegrass Water Utility Operating Company, LLC (Bluegrass Water) filed a motion requesting an informal conference to be held the week of March 16-20, 2026. By order issued March 18, 2026, the Commission granted Bluegrass Water's motion, and an informal conference (IC) was conducted on March 19, 2026. Attached is a copy of the attendance roster.

In its motion, Bluegrass Water stated the purpose of the IC was to discuss errors found in the financial workbook presented as Exhibit 9 to the Application and modifications to the procedural schedule in this matter.

Bluegrass Water, the Office of the Attorney General, by and through the Office of Rate Intervention, and Scott County all had representatives present. To begin the IC, Staff Attorney Whitney Saffari did introductions and reminded all parties that Commission Staff could not speak for the Commission.

Bluegrass Water stated that the extent of the error and impact on the application could not yet be determined. Counsel for Bluegrass Water shared a proposed amended schedule that would allow Bluegrass Water until May 8, 2026 to file its amended or corrected documents. Additionally, Bluegrass Water recognized that, if the error resulted in an increased rate request, customers would need to receive a modified notice.

The Attorney General's Office noted that there were no objections to extending the timeline, but asked several questions related to the suspension date and the impact of placing rates into effect by the suspension date. Bluegrass Water stated that if the application was deemed amended, the suspension date would more than likely also be updated. In addition, the Attorney General expressed concerns as to ensuring customer notice of any changes to the application's requests. Scott County expressed a desire to be able to maintain this current "docket" in order to utilize any correct information already provided in response to requests for information.

Bluegrass Water informed Commission Staff that it planned to file a motion requesting an amended procedural schedule and explain the workbook error, although the specifics on the extent of the impact would still be unknown.

There being no further discussion, the IC was then adjourned.
