State the nature of your concern: We live in Scott Co KY in the MOONLAKE Subdivision. 2 years ago the New Sewer Co raised our rates over 400 % .. This company has filed the intention to seek another rate increase . They wanted over 600% last time. Our sewer alone the bill jumped from 12.50 to 77.77 every month . There is no other game in the area and we don't have enough land for a septic system . I am retired and I work in my

wood shop every day . I saw the sewer company in our area twice in the past 2 years . Once when they did something at the pump station and again they had a contractor doing smoke test on the system . I don't know what they spent ant of the last rate increase on . Where does this stop when they get enough . We can't afford another rate increase at this time It jumped \$65 per month the last time and when you are on social security (fixed) income it make us rethink what we really need . I have heard neighbors talking about moving , another person thought he had his house and lot sold until the buyer heard about their intent to raise rates again. Please take a close look into this action we the customers feel like that we are getting taking advantage of because we are in a bad spot and they just keep squeezing. Please look into this if they state they did a bunch of work in this area I call BS on that I've seen them in the area twice in 2 yrs.and once was a routine test . William Daniel
