5. This case shall stand being submitted for a decision by the Commission effective 12:01 a.m. Eastern Daylight Time, July 30, 2026.

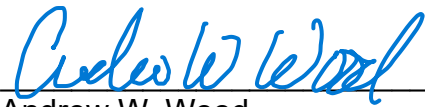
