ORDER

On December 24, 2025, Sam Gollihue (Complainant) filed a complaint against Kentucky Power Company (Kentucky Power) alleging that he was improperly charged a commercial rate for electricity.¹ On April 8, 2026, the Commission entered an Order requiring Kentucky Power to satisfy the matter complained of or file a written answer.² On April 17, 2026, Kentucky Power filed an Offer to Satisfy the Formal Complaint (Offer), offering re-bill Complainant at the residential rate from March 24, 2024, to May 29, 2025, refund Complainant's deposit in the amount of \$838, and to fully waive the deposit that would otherwise be required for Complainant's residential account.³

The Commission finds that Complainant should have 20 days from the service date of this Order to respond to Kentucky Power's Offer. If Complainant does not respond

within 20 days from the service date of this Order, the case shall be dismissed and removed from the Commission's docket.

IT IS THEREFORE ORDERED that:

1. Complainant shall have 20 days from the service date of this Order to respond to Kentucky Power's Offer.

2. If Complainant does not respond within 20 days, the case shall be dismissed and removed from the Commission's docket.

3. A copy of this Order shall be served by U.S. Postal Service, First-Class Mail and Certified Mail, Return Receipt Requested, on Sam Gollihue at 109 Baldrige Ct., Ashland, Kentucky 41101.
