Dear Ms. Cave:

Commission Staff has reviewed the application in the above case. This filing is rejected for the reason(s) set forth below.

Filing deficiency pursuant to:

1. 807 KAR Section 15 (2)(d)(1): Three (3) copies (one (1) in portable document format on electronic storage medium and two (2) in paper medium) of maps to suitable scale showing the location or route of the proposed construction or extension, as well as the location to scale of like facilities owned by others located anywhere within the map area with adequate identification as to the ownership of the other facilities.
2. 807 KAR Section 15 (2)(d)(2): Plans and specifications and drawings of the proposed plant, equipment, and facilities.
3. KRS 322.340: Engineering plans, specifications, drawings, plats and reports for the proposed construction or extension prepared by a registered engineer, must be signed, sealed, and dated by an engineer registered in Kentucky.

Additionally, as Apache Gas is requesting a change to its PRP surcharge, the Application is deficient for failing to meet the requirements laid out in 807 KAR 5:011, including but not limited to Sections 6, 8, and 9.

The information necessary to cure the deficiency must be submitted within 10 days of the date of this letter.
