Pursuant to an Order issued on May 27, 2026, an informal technical conference (ITC) was conducted on June 2, 2026. Attached is a copy of the attendance roster.

The purpose of the informal technical conference was for Kentucky-American Water Company (Kentucky-American) to provide a technical presentation regarding its Application for a general adjustment of rates and certain schedules and exhibits filed in support of the Application. Kentucky-American discussed the development of the forecasted test year revenue requirement, forecasting methodologies, operating and maintenance expense drivers, acquisitions, rate design proposals, and cost-of-service study. Kentucky-American also discussed various schedules supporting the Application, including rate base, operating income, and cost of capital schedules, as well as the Company's proposed System Improvement Program (SIP). Kentucky-American then fielded questions from the parties regarding the presentation and the Application.
