Comments:

I strongly object to KAW's rate increase request in Case 2026-00094. KAW claims they need public funds to improve service reliability and safety. However, their actual field operations prove otherwise. In active Complaint Case No. 2026-00152, KAW has legally defaulted as of June 29, 2026, offering zero defense for attempting to force an illegal three-household shared-meter configuration on our property in direct violation of 807 KAR 5:066, Section 12. KAW is using predatory, non-compliant shortcuts to avoid capital investments while demanding higher rates from the public. The Commission should deny any rate increase to a utility displaying total procedural defiance and structural negligence.
