RE: Informal Conference of June 2, 2026

Pursuant to TeraWulf's motion filed May 27, 2026, and the Commission's Order entered June 3, 2026, an informal conference (IC) was conducted on June 2, 2026. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss the proposed Retail Electric Service Agreement among Big Rivers Electric Corporation, Kenergy Corp., and Justified DataPower LLC, a subsidiary of TeraWulf Inc. During the conference, the parties provided an overview of the proposed project and discussed the structure and operation of the Agreement, including market pass-through provisions, transmission service, projected load, and the proposed term of the Agreement. The parties also discussed anticipated economic development impacts associated with the proposed project, including projected investments, employment opportunities, and potential local tax benefits. Additionally, the parties discussed the requested expedited procedural schedule and the basis for the requested timing of Commission review. The parties then fielded questions regarding the proposed Agreement and the associated project.

There being no further discussion, the IC was then adjourned.
