**AFFIDAVIT**

Tim Loken, being duly sworn upon oath, deposes and states as follows:

1. My name is Tim Loken and I am Director – Regulatory Reporting and an Officer for Windstream Kentucky West, LLC (“WKW”). My business address is 4001 N Rodney Parham Rd., Little Rock, Arkansas, 72212.

2. I have personal knowledge of the facts stated herein. I am competent to testify to the facts, which are stated to the best of my knowledge and recollection.

3. In the Kentucky Public Service Commission’s September 27, 2002 Order in Administrative Case No. 381, carriers were ordered to file with the Commission their plans for use of high-cost federal support by September 1<sup>st</sup> of each year.

4. WKW estimates its Federal Universal Service support for 2014 will be approximately \$2,652,996.

5. All Federal USF support received, for WKW properties in the Commonwealth of Kentucky, will only be used for the provision, maintenance and upgrading of facilities and

services for which the support is intended, consistent with section 254(e) of the Communications Act of 1934, as amended.
