

- My name is Paul D. Gearheart. I am employed by TVD Broadband, LLC, in the position of Vice President. In this position, I am personally familiar with the Federal Universal Service support received by the Company and how the Company uses these funds.
- TVD Broadband was designated as an eligible telecommunications carrier by the Kentucky Public Service Commission.
- 3. Pursuant to the requirements of 47 C.F.R. § 54.314, TVD Broadband hereby certifies all federal high-cost support provided to the Company was used in the preceding calendar year (2012) and will be used in the coming calendar year (2014) only for the provisions, maintenance and upgrading of facilities and services for which the support is intended, as designated by the Federal Communications Commission consistent with Section 254€ of the Federal Telecommunications Act.
