## ATMOS ENERGY KENTUCKY DIVISION 2015 METER SAMPLING ANNUAL REPORT

Atmos Energy, Kentucky Division completed the 17<sup>th</sup> year of its statistical sampling of their meter population with following results:

A total of 3,523 meters were sampled, as set forth in the Kentucky Public Service Commission's Order (Case Number 99-059), dated August 24, 1999.

The meter sampling program continues to be excellent for both, the company and our customers, identifying poor performing meters and allowing quality meters to remain in service for an extended length of time.

Included are the results of the 2014 Meter Sampling Program. The results spreadsheet indicates that all meter groups passed. Additionally, 786 obsolete meters were removed from service and retired.
