ATMOS ENERGY KENTUCKY DIVISION 2018 METER SAMPLING ANNUAL REPORT

Atmos Energy's Kentucky Division completed the 19th year of its statistical sampling of their meter population with following results:

A total of 1,627 meters were sampled, as set forth in the Kentucky Public Service Commission's Order (Case Number 99-059), dated August 24, 1999.

The meter sampling program continues to be excellent for both the Company and our customers, identifying poor performing meters and allowing quality meters to remain in service for an extended length of time.

Included are the results of the 2018 Meter Sampling Program. The results spreadsheet indicates that all groups passed, as outlined in the ANSI Z1.4 sampling process. Additionally, 2402 obsolete meters were removed from service and retired based on age.
