The Public Service Commission has received the Petition for Confidential Treatment you filed on January 25, 2010 on behalf of Atmos Energy Corporation ("Atmos") to protect certain information filed with the Commission as confidential pursuant to Section 7 of 807 KAR 5:001 and KRS 61.870. The information you seek to have treated as confidential is identified as being contained in Atmos' responses to Commission and Attorney General's Data Requests in accordance with procedural Order dated December 15, 2009. The information is described as a map of current and proposed facilities in Bowling Green, Kentucky, system improvements, and rating agency reports and correspondence.

Your justification for having the Commission handle this material as confidential is that the public disclosure of the information would compromise Atmos' competitive position in the industry and result in an unfair commercial advantage to its competitors, as well as reveal trade secrets.

Based on a review of the information and pursuant to KRS 61.878 and 807 KAR 5:001, Section 7, the Commission has determined as follows:

(1) **Response to PSC D.R. No. 2-27:** Map of current or proposed facilities meets the criteria for confidential protection due to infrastructure details, and therefore confidentiality is **GRANTED**;
