Dear Sirs:

Pursuant to the PSC's Final Order in the above-referenced case, Ridgelea is required to file quarterly activity reports regarding its \$5.45 per month customer surcharge. These reports shall include the monthly surcharge billings and collections, the monthly surcharge bank statement, a detailed listing of payments from the account, and invoices supporting the payments. Please find attached the latest bank statement and the notifications from Farmdale Water District of monthly surcharge billings and collections.

The surcharge was instituted to pay for an Inflow and Infiltration study ("I&I study") mandated by the Division of Water. During this past quarter, Hall Environmental contractors completed a study of our Meadowbrook system and we are currently seeking bids from three or more qualified contractors to fix any problems found by Hall Environmental. In addition, we will begin the study of the Farmgate system within the next few weeks.

In addition, Ridgelea is obligated to notify the Commission of the following issue. The Commission approved the \$5.45 surcharge intending for 100% of its proceeds to fund the I&I study. However, Ridgelea has only recently learned that, contrary to an oral agreement we had made with Farmdale Water District (which does our billing and collecting), Farmdale has been keeping 15% of the surcharge revenues and remitting only 85% to Ridgelea. We have voiced our concerns about this to Farmdale, but they refuse to make any changes to adhere to the Commission's surcharge directives.


