Dear Sirs:

Pursuant to the PSC's Final Order in the above-referenced case, Ridgelea is required to file quarterly activity reports concerning its \$5.45 per month customer These reports shall include the monthly surcharge billings and surcharge. collections, the monthly surcharge bank statement, a detailed listing of payments from the account, and invoices supporting the payments. Please find attached the latest bank statement and the notifications from the Farmdale Water District of monthly surcharge billings and collections.

The surcharge was instituted to pay for an Inflow and Infiltration Study mandated by the Division of Water ("DOW"). Our last quarterly report mentioned that a study was completed of the Meadowbrook system. However, the DOW was not satisfied with the smoke-test results of that study, and subsequently required a closed-circuit video survey of Meadowbrook. This video survey was completed within the past few weeks, and found that a conservative minimum estimate to repair the 1.000-foot sewer line at Meadowbrook would cost \$60,000. A more comprehensive replacement of the entire line and addition of some needed manholes would cost \$120,000 or more.

Importantly, the video survey found that most of the leakage problems in the sewer lines were caused by root intrusions from water maple trees. Meadowbrook is a very old neighborhood with many water maple trees, and some of these trees may need to be cut down to fully address the problem.
