Dear Sirs:

Pursuant to the PSC's Final Order in the above-referenced case, Ridgelea is required to file quarterly activity reports regarding its \$5.45 per month customer surcharge. These reports shall include the monthly surcharge billings and collections, the monthly surcharge bank statement, a detailed listing of payments from the account, and invoices supporting the payments. Please find attached the latest bank statement and the notifications from Farmdale Water District of monthly surcharge billings and collections.

The surcharge was instituted to pay for an Inflow and Infiltration study ("I&I study") mandated by the Division of Water. During this past quarter, Hall Environmental contractors visited the Farmgate system to video that system, and is currently preparing a report of its findings. Ridgelea anticipates that Hall will soon begin video work on the 3rd and final Mulberry plant in the very near future.

The PSC approved the surcharge for a 24-month period starting approximately two years ago, and therefore the last of the surcharge bills was issued and will be collected in July. Ridgelea therefore anticipates that our final surcharge report to the PSC should be forwarded at the end of September 2013.
