Pursuant to the PSC's Final Order in the above-referenced case, Ridgelea is required to file quarterly activity reports concerning its \$5.45 per month customer surcharge. These reports shall include the monthly surcharge billings and collections, the monthly surcharge bank statement, a detailed listing of payments from the account, and invoices supporting the payments. Please find attached the latest bank statement and the notifications from the Farmdale Water District of monthly surcharge billings and collections.

The surcharge was instituted to pay for an Inflow and Infiltration Study mandated by the Division of Water ("DOW"). Since our most recent quarterly report filed in June 2013, our contractor has completed the I&I Study for the Farmgate system and is awaiting its approval from the EPA. Once that approval has been received, the contractor will begin the I&I Study for the third and final system, which is Edgewood. In addition, please note that the surcharge was ceased in July 2013, in conformity with the PSC Order that established it.
