Big Sandy Rural Electric Cooperative Corporation, Fleming-Mason Energy Cooperative, Inc., Grayson Rural Electric Cooperative Corporation, and Jackson Energy Cooperative (collectively "Joint Applicants") hereby file their second report on the approved pilot program pursuant to the Commission's December 16<sup>th</sup> Order.

The Joint Applicants and the Mountain Association for Community Economic Development (MACED) launched the KERR pilot (marketed as How\$martKY) in April 2011 after a few months of additional program development after approval of the tariff rider application. The first two retrofits were reported in June 2011. In August, after consultation with the Joint Applicants, MACED decided to provide additional direct support in implementing the program by hiring an Energy Advisor to work directly with Joint Applicant staff to conduct assessments, prepare work scopes, recruit contractors, and manage the retrofit process.

To date, the pilot has conducted 81 assessments, of which 69 moved forward. Ten of the 69 have fully completed their retrofits and have had monthly charges assigned to their bills. The remaining homes are in the pipeline, with seventeen of those pending only quality assurance test-out or final paperwork. Customer response has been positive so far.
