

## JOINT MOTION TO PERMIT WITHDRAWAL OF MOTION TO REOPEN

Come now Grayson Rural Electric Cooperative Corporation ("Grayson"), by and through counsel, and East Kentucky Power Cooperative, Inc. ("EKPC"), by and through counsel, and for their joint motion to permit the withdrawal of the Motion to Reopen the above-captioned proceeding filed herein by Grayson on April 17, 2014 ("Motion to Reopen"), respectfully state as follows:

On or about May 15, 2015, Grayson, EKPC, and other interested parties executed a settlement agreement ("Settlement") that resolves many of the various issues and points of contention that have been raised in this and other proceedings involving Grayson and EKPC. Pursuant to the terms of the Settlement, Grayson has agreed to no longer pursue any relief in this matter. Accordingly, Grayson and EKPC request that the Commission permit the withdrawal of the Motion to Reopen and further hold that any outstanding motions or other materials filed herein be denied as moot and/or held for naught.

WHEREFORE, Grayson and EKPC respectfully request an Order from the Commission permitting the withdrawal of Grayson's Motion to Reopen filed herein on April 17, 2014.
