RE: In the Matter of Duke Energy Kentucky, Inc., Alleged Failure to Comply with KRS 287.042, Case No. 2010-00248

To Whom It May Concern:

In regards to the above case, Duke Energy Kentucky has completed the inspection for ground clearances for all of our medium-voltage conductors (1,000 to 35,000 volts) within the Duke Energy Kentucky Service area. The inspection encompassed approximately 333 sq. miles of facilities throughout our entire service territory, including Boone, Campbell, Kenton, Grant, and Pendleton counties. The Company performed these inspections as part of its regular line inspection protocols, with specific focus on the ground line clearances as agreed to in the aforementioned proceeding.

During these inspections, Duke Energy Kentucky's line inspectors identified 63 locations of concern and took corrective action to resolving these issues. These 63 locations of concern were evaluated base upon the applicable version of the National Electric Safety Code with respect to the vintage or age of the facilities in question. Areas identified as needing corrective action were prioritized and efforts were undertaken to resolve the particular concern. The method of resolution for the particular concern varied based upon the type of concern and whether the concern was with Company equipment or that of a third-party attachment. The necessary resolutions included re-sagging conductions, notifying communication companies to make adjustments, and replacing poles and wires.

As of March 25, 2013 all identified locations have been resolved. Attachment A is a listing of the locations and resolution completion dates.
