affiliate company must also appear on all affiliate company employee uniforms. In compliance with the Order, new uniforms have been ordered and are currently being manufactured. The new uniforms will bear both the name of "Atmos Energy" and the name of the affiliate, "Atmos Energy Holdings", as shown by the attached **Exhibit "A".** These new uniforms will be worn by all field personnel of any Atmos affiliate company who normally wear such company uniforms. This will be implemented by November 10, 2011.

Likewise, affiliate company vehicles and equipment bearing the name "Atmos Energy", will also bear the affiliate company name, such as "Atmos Gathering Company", "Atmos Energy Holdings" or "Atmos Energy Marketing". See the attached **Exhibit "B"** for example.

Uniforms and vehicles of the affiliate companies were the only "in print format" items specifically addressed in the Order. There are several other categories of "in print format" items which are used by Atmos and its affiliates throughout the states it serves that are not addressed, some of which Atmos believes are not intended to be severed by the Order. These sategories consist of the

- Hard hats bearing the name "Atmos Energy"
- Safety vests bearing the name "Atmos Energy"
- Line locate flags-see Attached Exhibit "G"
- Rectifier signs-see Attached Exhibit "H"

- Signs for affiliate company facilities and offices

Items used as gifts for associates, customers and distributed at public awareness

the Commission prior to use in any "<u>advertisement"</u>. In compliance with KRS 278.2213(13), the Commission promulgated regulations governing use of affiliate disclaimers in 807 KAR 5:080, Section 6. Subsection (2) of 807 KAR5:080, Section 6, requires that the disclaimer must appear in capital letters on the first page or at the first point where the utilities name or logo appears "in print format". Given the language of KRS 278.2213(13) which requires use of a disclaimer only in an "advertisement" by a regulated utility's affiliate, there are numerous items used by Atmos' affiliates which are for informational or safety purposes only – not advertisement.

I – PUBLIC AWARENESS/RP1162 MATERIALS and II – FIELD SAFETY & OPERATIONAL MATERIAL AND APPAREL

These primarily involve operational and safety matters – not advertisement or marketing

matters. For example, public service and safety items such as the "Call Before You Dig" handouts and

stickers, "Damage Prevention Awareness" brochures and "Caution High Pressure Pipeline" stickers .

As for "Promotional Items", these have occasionally been given away by representatives of

Atmos Energy Marketing. Since they are intended for advertising/promotional purposes, Atmos Energy

Marketing personnel will cease use of giveaways containing only the name of "Atmos Energy".

OTHER MEDIA

None of Atmos' affiliate companies operating in Kentucky engage in radio or television

advertising. The only affiliate operating in Kentucky that continues to have a website is Atmos Energy




