Re: INFORMATIONAL NOTICE FARM TAP SERVICE TO BE PROVIDED BY FOREXCO, INC.

To Whom It May Concern:

Forexco, Inc. ("Forexco"), is currently constructing a natural gas gathering pipeline in Bell County. Forexco is contacting you because your property may be within one-half air-mile of this pipeline.

Kentucky law (KRS 278.485) requires every gas pipeline company obtaining gas from producing wells to provide service, upon request, to customers whose property is located within one-half air-mile of the company's producing gas well or gas gathering pipeline. Such natural gas service is commonly referred to as "farm tap service."

Forexco has received approval from the Kentucky Public Service Commission to offer farm tap natural gas service to customers within one-half air-mile of Forexco's gathering line upon such a customer's request. Service will initially be provided under the rates and regulations set forth in the attached tariff approved by the Commission by order dated April 18, 2012.
