**RE: Notice of Modification to the Lifeline Service Offering of Blue Jay Wireless, LLC
in Kentucky; Case No. 2013-00377**

Dear Mr. DeRouen:

Blue Jay Wireless, LLC (“Blue Jay”) has been designated by the Kentucky Public Service Commission as an Eligible Telecommunications Carrier for provision of wireless Lifeline services.¹ On June 5, 2014, Blue Jay submitted the details of its Lifeline offering in Kentucky and indicated that the Company would provide subscribers with 350 anytime voice minutes with text messages assessed at a rate of 1 minute per text message for sending and 1 minute per text message for receiving text messages. Blue Jay further explained that there would be no rollover minutes with the plan and that unused minutes would expire each month on the service expiration date.

Due to market considerations, Blue Jay has decided to improve its Lifeline offering in Kentucky. The details of Blue Jay’s new service plan are as follows:

500 FREE Minutes/Texts Every Month. Each month the customer will receive 500 free anytime voice minutes. Text messaging will be assessed at a rate of 1 minute per text message for sending and 1 minute per text message for receiving text messages. There are no rollover minutes with this plan. Unused minutes will expire each month on the service expiration date.
