## MOTION TO AMEND APPLICATION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

Sage Telecom Communications, LLC d/b/a TruConnect ("TruConnect" or the "Company"), by its undersigned counsel, pursuant to Section 214(e)(2) of the Communications Act of 1934, as amended, (the "Act")<sup>1</sup>, Sections 54.101 through 54.207 of the Rules of the Federal Communications Commission ("FCC")<sup>2</sup>, and the rules and regulations of the Kentucky Public Service Commission ("Commission"), hereby submits this Motion to Amend Application for Designation as an Eligible Telecommunications Carrier in the Commonwealth of Kentucky for the Limited Purpose of Offering Wireless Lifeline Service.

Due to internal corporate restructuring, TruConnect hereby moves the Commission to amend Company's application to reflect its name change from Sage Telecom Communications, LLC to Sage Telecom Communications, LLC d/b/a TruConnect. Attached as Exhibit A is the Secretary of State filing reflecting Company's new name in the state of Kentucky.

Additionally, pursuant to the 2016 FCC *Lifeline and Link Up Reform and Modernization Order*<sup>3</sup>, Sage clarifies and amends its Lifeline service offerings as follows as described in detail in Exhibit B. Sage's proposed Lifeline plans will be effective December 2, 2016.

In support of its Application, Sage states as follows:

- 1) Pursuant to 807 KAR 5:001, Section 14(1):
  - (i) the full name of the applicant is Sage Telecom Communications, LLC d/b/a TruConnect;
  - (ii) the mailing address of the applicant is 10440 North Expressway, Suite 700, Dallas, Texas 75231; and
  - (iii) the electronic mailing address of the applicant is <a href="mailto:nlaw@truconnect.com">nlaw@truconnect.com</a>.
- 2) Pursuant to 807 KAR 5:001, Section 14(3):
  - (i) TruConnect was established in 1998 in Texas;
  - (ii) TruConnect states that it is currently in good standing in the Commonwealth of Kentucky; and
  - (iii) TruConnect states that it is authorized to transact business in Kentucky.

WHEREFORE, TruConnect respectfully requests that the Commission amend its Application in this docket to reflect the Company's new name and Lifeline plan offerings.
