Status Report # 3 on Transfer of Wastewater Facilities

Case No. 2014-00425

Dear Mr. Derouen:

On February 13, 2015, the Kentucky Public Service Commission (PSC) entered an Order approving the transfer of the wastewater facilities, services and customers of the Estill County Water District No. 1 (Estill No. 1) to the City of Irvine through its Irvine Utility Commission (IMU). Paragraph No. 8 of this Order requires Estill No. 1 to provide a Status Report of its efforts to complete this transfer within 60 days. This Status Report # 3 is as follows (the Items shown as complete in Status Report # 2 will not be repeated in Status Report # 3):

- 1. <u>USDA Loan:</u> Paragraph 3 of the Agreement requires IMU to assume liability for the USDA Loan of \$307,000.00 as of October 20, 2014. In February of 2015, Estill No. 1 made a payment on this loan in the amount of \$20,675. By April 13, 2015 letter, USDA notified Estill No. 1 that IMU had paid the loan balance of \$298,224.65. By an April 8, 2015 email, USDA notified Estill No. 1 that this payment of the loan balance would relieve Estill No. 1 of any further liability under this loan. A copy of the April 8, 2015 email and a copy of the April 13, 2015 letter are attached for filing in the general correspondence file of Estill No. 1. Estill No. 1 and IMU have completed all fund transfers as documented by the attached July 17, 2015 letter from Michael Eaves, the attorney for IMU. Please file a copy of this letter in the general correspondence file of Estill No. 1.
- Decommission Plant: Paragraph 5 of the Agreement requires that Estill No. 1
  decommission its plant. This plant has been decommissioned under a Closure Plan
  submitted to the DOW on October 27, 2014 and approved by the DOW. DOW has
  completed its inspection of the decommissioned plant and Estill No. 1 is waiting on an
  Agreed Order of Dismissal from the Energy and Environment Cabinet.

- Agreed Order of Dismissal: Paragraph 13 of the Agreement requires that IMU and Estill
  No. 1 execute an Agreed Order of Dismissal of the litigation filed in Estill Circuit by IMU.
  This provision is now complete and a copy of the Agreed Order of Dismissal as Settled
  which was entered on July 31, 2015 is attached. Please file a copy of this Order in the
  general correspondence file of Estill No. 1.
- 4. Relief from Fines and Penalties: Paragraph 14.b. of the Agreement provided that the Agreement is contingent on the written assurances that Estill No. 1 would be relieved from responsibility for any fines, assessments or penalties for its prior activities. The Closure Plan has been completed including the fill material, reseeding and other various activities. DOW has completed its inspection of the decommissioned plant and Estill No. 1 is waiting on an Agreed Order of Dismissal from the Energy and Environment Cabinet.

In summary, only the above items require additional documentation.

Pursuant to the provisions of the Commission's Order entered into the above case on February 13, 2015, and on behalf of the City of Irvine Utility Commission, please accept this as notice that the provisions of the Settlement Agreement between Estill County Water District No. 1 and the City of Irvine Utility Commission for the takeover of the wastewater treatment facilities and operations is now complete. Specifically, all federal and state approvals that were required, have been obtained; such accounts receivable documentation as has been requested by the Irvine Municipal Utilities has been delivered to them; the easements granting Irvine Municipal Utilities the use of property over which the Water District's sewer lines and facilities are located have been conveyed by the District to the City; USDA loan to the District has been paid by the City of Irvine; the Water District's sewer plant has been decommissioned and as we understand it, closed and such closure approved by the Division of Water, the enclosed Agreed Order of Dismissal has been executed by counsel for both the Water District and IMU and has been sent to the Estill Circuit Court for entry; based upon the information provided us by the District, all fines and assessments against the District for previous transgressions have been waived; all the District's personal property and equipment utilized in the operation of its sanitary sewage disposal operation have been transferred to the City of Irvine; and the Water District and the City of Irvine have recently compromised the sums due the City from the Water District for sewage treatment services it previously offered and for which the District was paid.

facilitate the quick and orderly transfer of this facility. We believe the residents of Estill County and of Irvine have all mutually benefited by it.
