**AMENDMENT TO LARGE VOLUME
NATURAL GAS SERVICE AGREEMENT**

THIS AMENDMENT is made and entered into as of the 12th day of October 2016, by and between ATMOS ENERGY CORPORATION, a Texas and Virginia Corporation ("Atmos Energy"), and [REDACTED], A [REDACTED] corporation ("Customer").

WITNESSETH:

WHEREAS, on February 1, 2016, Atmos Energy and Customer entered into a Large Volume Natural Service Agreement (the "Agreement"), whereby Atmos Energy agreed to supply natural gas service to Customer, and

WHEREAS, for the Agreement to become effective per the terms of Section 3, approval by the Kentucky Public Service Commission ("KPSC") is required, and

WHEREAS, the KPSC has conditionally approved the Agreement in Case No. 2016-00052 subject to the filing of an amendment requiring the Customer to be responsible for any additional investment required by Atmos Energy to serve the Customer,

NOW, THEREFORE, Atmos Energy and Customer agree as follows:

1. Customer shall be responsible for any additional investment required by Atmos Energy to serve Customer.
2. All other provisions of the Agreement are hereby confirmed by the parties to be and remain in full force and effect.
