## REPORT OF ACTION Prepared February 10, 2017

Reference is made to the order entered into on December 16, 2015, which requires the Company to make a report to the Commission concerning the issuance of securities under the \$2,500,000,000 universal shelf registration.

Atmos hereby reports:

On March 28, 2016, we entered into an at-the-market (ATM) equity distribution agreement (the Agreement) with Goldman, Sachs & Co., Merrill Lynch, Pierce, Fenner & Smith Incorporated and Morgan Stanley & Co. LLC in their capacity as agents and/or as principals (Agents). Under the terms of the Agreement, we may issue and sell, through any of the Agents, shares of our common stock, up to an aggregate offering price of \$200 million, through the period ended March 28, 2019. We may also sell shares from time to time to an Agent for its own account at a price to be agreed upon at the time of sale. We will pay each Agent a commission of 1.0% of the gross offering proceeds of the shares sold through it as a sales agent. We have no obligation to offer or sell any shares under the Agreement, and may at any time suspend offers and sales under the Agreement. The shares will be issued pursuant to our shelf registration statement filed with the SEC on March 28, 2016 that originally permitted us to issue, from time to time, up to \$2.5 billion in common stock and/or debt securities.

During the first fiscal quarter of 2017, Atmos Energy Corporation sold 690,812 shares of common stock for \$49.99 million and received net proceeds of \$49.49 million. During the calendar year of 2016, Atmos Energy Corporation sold 2,051,568 shares of common stock for \$149.99 million and received net proceeds of \$148.49 million. As of December 31, 2016, \$2.35 billion of securities remain available for issuance under the shelf registration statement and approximately \$50 million of equity remain available for issuance under the ATM program.
