**FARMDALE DEVELOPMENT CORPORATION'S MOTION FOR EXTENSION OF  
TIME TO FILE GROSS REPORT**

Comes Farmdale Development Corporation ("Farmdale Development"), by counsel, and hereby moves the Public Service Commission for an extension of time through October 31, 2017, within which to submit its Gross Report for the time period beginning on January 1, 2017, and ending on August 1, 2017.


1) On July 24, 2017, the Commission entered its Order approving the transfer of the Farmdale Development wastewater treatment plant and collection system ("WWTP") to the Farmdale Sanitation District. Paragraph 6 of this Order required Farmdale Development to submit its Gross Report for the time period January 1, 2017, through the date of transfer by no later than August 31, 2017.

2) The transfer of the Farmdale Development WWTP to Farmdale Sanitation District was completed, effective August 1, 2017.

3) Due to Farmdale Development's billing cycle, Farmdale Development will not receive payment for the sanitary sewer collection and treatment services provided to its customers through August 1, 2017, until October, 2017. Therefore, it will not be able to prepare a complete Gross Report until October, 2017.

4) For the above-stated reasons, Farmdale Development requests an extension of time through October 31, 2017, in which to complete its Gross Report.


