RE: Green-Taylor Water District Alternative Rate Filling Application Case No. 2018-00030

As part of the above Alternative Rate Filing Application a discrepancy was found in the billing for two trailer parks. In paragraph 4 and 5 of the Public Service Commission Order it is stated that:

- 4. Green-Taylor Water District shall file with the Commission a report of the actions taken to prevent customers being charged incorrect rates.
- 5. Green-Taylor Water District shall file with the Commission a report on what actions it will take to collect any uncollected revenue due from the two commercial customers that were undercharged.

Green-Taylor respectfully submits the following response to the above orders:

4. After some research, we were able to find when the discrepancy first occurred. We discovered a Rate and Tariff update from 1995 which was prepared by our Bonding Counsel during a line extension. Evidently the trailer park rates were inadvertently missed when the rates were sent in for approval and it was just never noticed. It would have been missed this time also, except the rates from the computer were used for calculation rather than just updating the tariff sheets.

As discussed in our response letter dated 2/28/2018, the rates for the Large Trailer Park and Small Trailer Park have been discontinued and deleted from the computer, so they cannot be used in the future. The trailer park accounts have been updated to 2 Inch and 1 Inch Commercial Rates.

In the future, the rates in the computer will correspond with the rates in the tariff, so something like this will not happen again.

5. According to KRS 278.225 "All service supplied by a utility shall be billed within two (2) years from the date of the service. No customer shall be liable for unbilled service after two (2) years from the date of the service, unless the customer obtained the service through fraud, theft, or deception."

We went back through the two accounts and calculated the bills according to the correct rate chart. We then subtracted the amount they were actually charged and obtained the following amount each was undercharged:

Large Trailer Park \$577.09 Small Trailer Park \$513.35. These accounts will be sent a letter explaining the discrepancy and the amount they owe, and payment arrangements will be made that are satisfactory to both parties, but within the two years allowed for repayment.

During the recent rate filing Application with the Public Service Commission a discrepancy was found in the way that Green- Taylor Water District has been charging for trailer park water sales. The rates that were being used in the billing software were labeled small or large trailer park rates and Public Service Commission stated it should be a 1- inch or 2-inch Commercial Rate charge not a small or large trailer park rate. Public Service stated that Green- Taylor Water District was to go back over a two-year period and collect the lost revenue from the incorrect billing. This can be found in the KRS 278.225 regulation "All service supplied by a utility shall be billed within two (2) from the date of finding.

Green- Taylor Water District has went back through the account and calculated the bills according to the correct rate chart. We then subtracted the amount that was actually charged and obtained the lost revenue to be collected for undercharging. In the future the rates for large or small trailer parks have been taken out of the billing and it now states either a 1-inch or 2-inch commercial charge for trailer parks. Payments can be arranged in either a 1-year or 2-year payment agreement with the Green- Taylor Water District. Green- Taylor Water District is sorry for the inconvenience this has caused.
