EVALUATION OF POSSIBLE GAS SUPPLIER

Pursuant to the Public Service Commission's ("Commission") Order entered in the above case on July 12, 2018, Sentra Corporation, by counsel, hereby files its Evaluation of Possible Gas Supplier.

- 1. The Commission's Order of July 12, 2018, required Sentra Corporation to provide to the Commission an evaluation of possible gas suppliers within sixty (60) days of the completion of the acquisition of the Sentra Corporation shares of stock. The closing of the acquisition of Sentra Corporation shares of stock took place on Friday, October 12, 2018.
- 2. Sentra Corporation has evaluated CenterPoint Energy Services, a subsidiary of CenterPoint Energy (headquartered in Houston, TX). CenterPoint Energy Services offers competitive natural gas supply and related energy services for gas utilities, large industrials, electric generators, small commercial customers, municipalities, educational institutions, governmental facilities, hospital systems and more.
- 3. CenterPoint Energy Services reports: a) that it is one of nation's top 12 natural gas marketers based on volume; b) that it has over 100,000 end-use customers; c) that it serves customers in 32 states; and d) that it provides over 1 trillion cubic feet of natural gas to its

customers.

- 4. The services of CenterPoint Energy Services include: a) load forecasting; b) supply acquisition; c) daily swing volume management; d) invoice consolidation; e) storage asset management, e) firm and interruptible transportation administration; f) forward physical price management; and, g) management services like budgeting and other tools to maintain fair prices for our customers. The capability of CenterPoint Energy Services to store natural gas can help utilities like Sentra Corporation to control costs.
