Mr. Lipham,

In response to your inquiry, in Case No. 2018-00117, Ledbetter Water District (Ledbetter) requested to increase its water and sewer rates. The Commission ordered a two-phase rate increase on September 10, 2018. On September 24, 2019, and again on June 26, 2020, Ledbetter requested to postpone the Phase 2 sewer rate increase until July 2020 to lessen the impact of higher sewer bills. In order to maintain Ledbetter's financial stability, the Commission required Ledbetter to implement the Phase 2 sewer rate increase, effective August 20, 2021.

The Commission has a statutory duty to ensure that rates are fair, just, and reasonable, and that the customers receive safe, adequate, and reliable utility service. That duty necessitates that the Commission balance the need for utilities to collect adequate rates to maintain the financial stability to provide that service, and efforts to assure the affordability of utility service for every Kentuckian.

Your comments were filed into the case record of Case No. 2018-00117 and will receive due consideration by the Commission.
