Pursuant to 807 KAR 8:069, Section 4 and Ordering Paragraph #7 of the PSC Order dated October 7, 2019 in Case Number 2019-00346, the Mountain Water District hereby notifies the Kentucky Public Service Commission of the following additional construction regarding the Mountain Water District's Radio Read Meter Replacement Project. The District plans to utilize the remaining funds plus a small amount of our own funds to construct the following additional work items:


- Purchase and installation of zone meters with upgrades or installation of telemetry for same.
- The purchase of service and main line materials for replacements.
- Long Fork Service Line Replacement Project performed by a contractor.
- Main line replacements performed by a contractor.
- Various leak detection and other equipment to aid the District in leak detection activities and line replacements.
- Replacement of two (2) water storage skid tanks.

No change in rates will result from this additional construction.
