I dispute the validity of the debt of \$1474.30 under KRS 413.120 as Kentucky Time Barred for contracts is defined under KRS 413.120 which states five years, the applicable time limit for pursuing legal action or collecting a service contract. I declare Ky Time Barred under KRS 413.120 as the statute of limitations has passed.

LGE has transferred \$1474.30 from 2013 to LGE Accounts: [REDACTED] in November 2022 and [REDACTED] on 07/05/2023 for Service at Address 1153 Ellerholt Court Louisville KY 40211 refusing service and extorting payments of this debt I do not owe.

Any payments made towards the debt of \$1474.30 in November 2022 and July 2023 were due to extortion tactics listed under KRS Title 51 as LGE is a monopolistic business entity and refused services until payment arrangements were made in November 2022 and Payment in Full of \$1474.30 again on 07/05/2023.

Their collection attempts have been harassing, abusive and damaging to my disabilities with a disregard for many of my state and federal civil rights according to FDCPA, The Consumer Protection Bureau, KRS Title 51, KRS 413.120 and the ADA. Pursuant to the Fair Debt Collection Practices Act (FDCPA), I am exercising my right LGE discontinues all attempts at collecting this debt of \$1474.30 under KRS 413.120 as this debt is time barred.

Any further attempts to collect this time-barred debt of \$1474.30, threats or acts of disconnect for LGE Account [REDACTED] at service address 1153 Ellerholt Court Louisville KY 40211 is against my rights according to KRS 413.120 and defined as extortion under KRS Title 51; Else, I will be forced to file this as criminal.

Cease and desist all attempts at collection, all attempts and threats of disconnection for LGE Account [REDACTED] at Service address 1153 Ellerholt Court Louisville KY 40211 as this debt is time barred under KY KRS 413.120 and LGE is in violation of my rights under KRS Title 51, FDCPA, Consumer Protection Bureau and the ADA and will be held legally liable for damages caused.
