The order issued by the Kentucky Public Service Commission on Case No. 2006-00367 dated September 14, 2006 stipulates the following:

- Three years from the effective date of this Order, Whitley County shall file an
  income statement, along with any pro forma adjustments, in sufficient detail to
  demonstrate that the rates approved herein are sufficient to meet its operating
  expenses and annual debt service requirements.
- Whitley District shall file a copy of the "as-built" drawings and a certified statement that the construction has been satisfactorily complete in accordance with the contract plans and specifications with 60 days of the substantial completion of the construction certified herein.

Please report to us in writing the status of these issues by February 8, 2010.
