2012 METER SAMPLING ANNUAL REPORT

Atmos Energy, Kentucky Division completed the 14th year of its statistical sampling of their meter population with following results:

A total of 4,069 meters were sampled, as set forth in the Kentucky Public Service Commission's Order (Case Number 99-059), dated August 24, 1999.

The meter sampling program continues to be excellent for both the company and our customers, identifying poor performing meters and allowing quality meters to remain in service for an extended length of time.

Attached are the results of the 2012 meter sampling program. The results spreadsheet indicates that all meter groups passed. Additionally 1,637 obsolete meters were removed from service and retired along with the 2012 sampling program.
