Dear Mr. Derouen:

Pursuant to the Settlement Agreement December 14, 2011 on the above stated case, I have enclosed a summary of the inspection of mobile home parks located within South Kentucky RECC Service Territory. While performing this inspection we also included clusters of mobile homes located in close proximity to each other which may not be classified as a mobile home park.

South Kentucky personnel inspected 183 mobile home parks and/or clusters of mobile homes. All high voltage primary lines around and near these mobile home parks and/or clusters met the National Electric Code clearance requirements.

We did address 15 separate clearance issues involving low voltage triplex lines. Fourteen of these involved mobile homes and we discovered one triplex wire laying on the roof of a garage.

Of the fifteen clearance issues found we retired two triplex wires which were not in use, straightened one service pole, changed three service poles and raised the triplex wire on nine services to meet clearance.

This completes our commitment to the above mentioned Settlement Agreement entered into by South Kentucky R.E.C.C. and the Kentucky Public Service Commission.
