

Thank you for your letter dated May 8, 2012 concerning Farm Tap service in Brush Mountain Farms, Bell County, KY. I may be interested in the service but need additional information to help me make an informed decision. My questions are:

1. Is the rate of \$9.98/Mcf fixed, or will it be subject to change over time?
2. Where will I tap on the line? In other words, will I be responsible for running the line from your pipeline to my property, or do you do that, or something else?
3. Is there a time limit on accepting the offer? If so, what is the end date?
4. Once the tap is bought, is there a guarantee that natural gas will always be available, even if the wells you install in the area are no longer pumped?




