The six contracts are:



Each of the contracts above previously was filed with the Commission. The Commission approved the withdrawal of the coal provisions of Tariff C.S.-I.R.P. by Order dated January 13, 2021 in Case No. 2020-00174.¹ Accordingly, no additional contracts containing the coal provisions of Tariff C.S.-I.R.P. will be entered into subsequent to that date. The Company will continue to file its semi-annual reports with respect to the existing contracts.
