- Contract 1 (KY Highway 109 vicinity) was substantially complete as of August 1, 2018.
 The Contractor (Horsley Construction) was notified on January 4, 2019 (letter attached).
 The Contractor continues to work on punch list items and final cleanup, all with payment of retainage pending.
- Contract 2 (US Highway 41 & KY Highway 1349) was substantially complete as of December 18, 2018. The Contractor (Horsley) was notified on January 4, 2019 (letter attached). The contract presently sits at 94% complete, as the Contractor continues to work on punch list items and final cleanup.
- The District expects a significant sum of leftover funds from the project. In accordance
