RE: Informal Conference of January 3, 2024

Pursuant to an Order issued on December 22, 2023, an informal conference (IC) was conducted on January 3, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Mountain Water District's wholesale water rate granted by the Commission in this matter. Mountain District reported it had received comments from one of its wholesale purchases, the city of Elkhorn, Kentucky (Elkhorn), regarding the substantial increase in the wholesale rate. Mountain District has concerns regarding Elkhorn's ability to pay its bills at the increased rate. Commission Staff provided an explanation as to the method of how the wholesale rate was calculated.

Mountain District also discussed possible actions it could take to alleviate the impact of the increased wholesale rate on Elkhorn. Commission Staff informed the participants that the Commission would consider any future applications or motions seeking such relief upon receipt from Mountain District or Elkhorn in the future.

There being no further discussion, the IC was then adjourned.
