LG&E shall pay \$15,000.00 of the \$32,500.00 civil penalty within 30 days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the Office of General Counsel, Kentucky Public Service Commission, 21 1 Sower Boulevard, Post Office Box 61 5, Frankfort, Kentucky 40602. 4. The remaining \$17,500.00 of the civil penalty is suspended on the condition that LG&E abide by the terms contained in the Settlement Agreement and provide all required documentation within the time allotted. 5. Within 30 days of the date of entry of this Order approving the Settlement Agreement, LG&E shall provide to the Commission documentation on the training given as a result of this incident, including the type of training, who attended, and how this training will be implemented into the training program on a regular basis. 6. LG&E currently performs safety audits of its substation crews. Within 30 days of the date of entry of the Settlement Agreement, LG&E shall provide to the Commission copies of the safety audits performed on all LG&E Louisville substations for the three month period prior to the date of the accident and for the three month period following the date of the accident. 7.
