Nichols Contracting shall pay \$1,250 within 30 days of service of this Order by cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the office of the Kentucky Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky 40602. 3. Record of payment of the civil penalty assessed by this Order shall be filed in the post-case correspondence file in this proceeding. 4. This case is closed and removed from the Commission's docket. THIS IS A FINAL AND APPEALABLE ORDER OF THE PUBLIC SERVICE COMMISSION. An application for a rehearing may be filed with the Commission within 20 days after service of this Order as provided by KRS 278.400.
