The remaining civil penalties assessed shall be suspended contingent upon Valley Gas continuing to use a third-party contractor, such as USDI, or another contractor approved in writing by DOI, to ensure compliance with all minimum federal safety standards, for a period of five years. 4. Valley Gas shall file a report annually no later than December 31 of each year, documenting its use of a third-party contractor. 5. The Commission shall consider payment of the suspended portion of the penalties to be satisfied upon Valley Gas's satisfaction of the conditions discussed above. 6. Any documents filed pursuant to ordering paragraph

4 shall reference this case number and shall be retained in the post-case correspondence file. 7. This

case shall be closed and removed from the Commission's docket.
